

PROTECTION OF CHILD RIGHTS POLICY

Sherwood Resorts & Hotels accepts every individual as a child according to every law which can be applied to a child, excluding the case of precocious puberty.

Sherwood Resorts & Hotels accepts that every child has the inherent right to life.

Sherwood Resorts & Hotels shows maximum potential effort for the survival and development of a child.

Sherwood Resorts & Hotels recognizes the right of every child who has the ability to form his/her opinions to Express his concerns, appropriate for his/her age or maturity level, freely on every subject provided that necessary attention is given. For that purpose, the opportunity to be listened directly or by an appropriate post or a representative, in line with the rules of national law procedure, is especially given to the child in case of any legal proceeding or administrative proceeding.

Sherwood Resorts & Hotels respects a child's freedom of thought, conscience and religion. Parents or if needed legal guardians respect their rights and duties on the subject of guiding the child in use of his/her rights compatible with his/her development of his/her abilities. One's freedom of expressing his religion or beliefs, provided it is envisaged and needed by law, can only be restricted by intendments of public security or order, health or moral or for protecting others' fundamental rights and freedoms.

Sherwood Resorts & Hotels is aware that any intervention can not be done arbitrarily or unfairly to the child's private life, residence and communication, an attack can not be carried out to his honour or reputation, a child has the right to be protected by law for these kinds of interventions or attacks.

Sherwood Resorts & Hotels accepts that every child has the right to a sufficient level of living which provides physical, psychological, mental, moral and social development.

Sherwood Resorts & Hotels accepts that every child has the right to education.

Sherwood Resorts & Hotels absorbs that every child guest or outside of our establishment who are a member of a religious or linguistic minority or a member of another origin can not be bereft of utilization of his/her culture with other members of his/her minority group, the right to believe or practice his/her own religion and use his own language.

Sherwood Resorts & Hotels recognizes a child's right to rest, recreation, play and participate in activities suitable to his/her age and participate in cultural and artistic life. It recognizes and encourages a child's right to fully participate in cultural and artistic life with respect and gives countenance to the providing suitable and equal opportunities on the subjects of (activities regarding) art and culture.

Sherwood Resorts & Hotels accepts a child's right to have protection from economical exploitation and any kinds of hazardous occupation or being employed in a way which may cause harm to his/her physical, psychological, mental, moral and social development.

Sherwood Resorts & Hotels takes every possible precaution, including legal, social and educational characteristics in an appropriate procedure described in international treaties, with the intention of protecting children from illegal use of drugs and psychotropic substances and preventing the use of children for these substances' illegal production and trafficking.

Sherwood Resorts & Hotels gives assurance of protecting every child from every kind of sexual exploitation and sexual abuse. For that purpose, it takes every necessary precaution on an international level and bilateral or multilateral relations for the purpose of preventing children from being deceived or being forced to an illegal sexual activity and preventing exploitation of children by making them participate in an illegal sexual activity or prostitution, being used in pornographic shows and materials.

Sherwood Resorts & Hotel protects children from any exploitation which may cause harm to his/her wellbeing in anyway.

Sherwood Resorts & Hotels embraces that no child can be subjected to any torture or other cruel, inhumane or degrading treatment and punishment.

Sherwood Resorts & Hotels are a part of children's rights and the child's rights protection policy for all employees to provide initial orientation training and executive agencies when given with child abuse in periodic education and cultural establishments, which requires the necessity to report to the appropriate provincial police officers.
